Sub: Extension of provisional temporary approval of affiliation to Global College of Law, Distt.Ghaziabad, Uttar Pradesh for three year LL.B as well as five year BA LL.B law courses for the academic year 2022-2023 with the prevalent/existing sections (earlier specifically approved in writing by BCI) with intake of not more than 60 students in one section.

Sir,

This is with reference to above mentioned subject regarding extension of provisional approval of affiliation Global College of Law, Distt.Ghaziabad, Uttar Pradesh which has already applied for extension of approval of affiliation for the academic year 2022-2023

This is to bring to your kind knowledge that the following resolution was passed on 08th June, 2022 by the General Council of the Bar Council of India with respect to grant of provisional approval of affiliation for academic year 2022-2023 for those centers of Legal Education which have applied for approval of affiliation for the academic year 2022-2023.

“RESOLVED that with respect to existing Centers of Legal Education/colleges, whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, such Centers of Legal

Education/colleges may continue to admit students only for the academic year 2022-2023. This will apply only in case where affiliation has been granted by the University, Such provisional approval shall be subject to any decision taken after the inspection of the CLE is done by the Bar Council of India subsequently.

It shall further be conditional and is subject to compliance as per circular dated 05.02.2020 bearing No.BCI:D:158 (LE:Circulation No.01/2020), issued to all Centers of Legal education, as per the extended time of such compliance which shall be 31st August, 2022, whereby every center of Legal Education/college shall be required to submit a certified authenticated bank statement bearing bank stamp, date and signature, mandatorily with respect to the salary/ies being disbursed to all the teachers/faculties every three months with effect from March, 2022 on a regular basis, unless specifically sought at other intervals, and also furnish list of teachers with qualifications as per BCI and UGC Rules, and further furnish proof/receipts of fulfilment of minimum library requirements, as enumerated under Schedule-III, Rule-15, Minimum Library requirements of Legal Education Rules-which is the sine qua non of a Center of Legal Education. Certain show cause notices and compliance letters had also been issued specifically to certain Centers of Legal Education/Colleges, with conditions mentioned therein, which have to be complied too as per the time stipulations therein, and if they have not been complied with they must be complied with immediately or latest by 31st August, 2022.

However, regardless of the date of 31st August, 2022 for compliance, an affidavit undertaking to comply with the conditions mentioned in the above referred circular and of all the rules of Legal Education, shall be required to be submitted by way of duly notarized affidavit within 15 days of receipt of this letter by way of hardcopy and also by way of scanned copy at complianceaffiliationle2@gmail.com with heading-COMPLIANCE TO PROVISIONAL APPROVAL-REQUIREMENTS

It is made clear that if any Center of Legal Education, fails to submit all the required documents as sought by way of the afore referred circular and the show cause notices (where applicable), and the compliance letters, already issued, by 31st August, 2022, then their application for extension of approval for 2022-2023 shall not be considered and, if, approval is granted for the academic session 2022-2023, it may be withdrawn too.





Since your University has given affiliation for the academic year 2022-2023, you are requested to allow **Global College of Law, Distt.Ghaziabad, Uttar Pradesh** to admit students in **three year LL.B as well as five year BA LL.B law courses** with the prevalent/ existing (earlier approved by BCI) sections, for the academic year 2022-2023





असाधारण गजट नोटिफिकेशन संख्या-975/79-वि-1-14-1(क)19/2014 दिनांक 18.07.2014 द्वारा उत्तर प्रदेश राज्य विश्वविद्यालय अधिनियम, 1973 (यथासंशोधित उत्तर प्रदेश राज्य विश्वविद्यालय संशोधन अधिनियम, 2007) की धारा-37(2) के परन्तुक के अधीन ग्लोबल कालेज ऑफ लॉ, नागलोक, कुशालिया पोस्ट हिण्डन नगर डासन, गाजियाबाद को विधि संकायान्तर्गत स्नातक स्तर पर बी०ए०एल०एल०बी० (पाँच वर्षीय) पाठ्यक्रम में स्ववित्त पोषित योजनान्तर्गत कतिपय शर्तों के अधीन शैक्षिक सत्र 2020-21 (दिनांक 01.07.2020) से आगामी पाँच वर्ष हेतु सम्बद्धता की पूर्वानुमति प्रदान की गयी है।

01. संस्था द्वारा उ०प्र० राज्य विश्वविद्यालय (संशोधन) अध्यादेश, 2003 द्वारा मूल अधिनियम, 1973 की धारा-37(2) में प्राविधानित परन्तुक के अनुसार सम्बद्धता प्राप्ति की तिथि से एक वर्ष की अवधि में सभी निर्धारित मानकों को पूर्ण कर लिया जायेगा अन्यथा अगले शैक्षणिक वर्ष में छात्रों का प्रवेश प्रतिबन्धित रहेगा।
02. कतिपय संस्थानों/महाविद्यालयों के सशर्त सम्बद्धता/सम्बद्धता की पूर्वानुमति के निर्गत आदेशों में इंगित कमियों यथा-प्राभूत का नवीनीकरण, अग्निशमन प्रमाण पत्र का नवीनीकरण व एन०बी०सी० प्रमाण पत्र सक्षम स्तर से निर्गत न होने की कमी का निराकरण किये जाने में यदि समय लगना सम्भावित हो तो विश्वविद्यालय उक्त महाविद्यालय के सम्बद्धता आदेश तत्काल निर्गत करते हुए उपरोक्त कमियों की पूर्ति से सम्बन्धित अभिलेख महाविद्यालयों से एक माह में प्राप्त कर लेगा।
03. संस्थान/महाविद्यालय सशर्त सम्बद्धता/सम्बद्धता आदेश में इंगित कमियों की पूर्ति कर लेगा एवं विश्वविद्यालय के कुलसचिव को इस आशय का प्रमाण पत्र प्रतिवर्ष प्रेषित करेगा कि संस्थान/महाविद्यालय सम्बद्धता की शर्त निरन्तर पूरी कर रहा है।
04. संस्था शासनादेश संख्या-2851/सत्तर-2-2003-16 (92)/2002 दिनांक 2 जुलाई 2003 में उल्लिखित दिशा-निर्देशों एवं इस विषय में समय-समय पर निर्गत शासनादेशों का पालन करेगी।
05. यदि संस्था द्वारा विश्वविद्यालय की परिनियमावली/अध्यादेश में वर्णित तथा शासन एवं विश्वविद्यालय द्वारा निर्धारित शर्तों एवं मानकों की पूर्णता एवं उनकी निरन्तरता को सुनिश्चित नहीं किया जायेगा तो उत्तर प्रदेश राज्य विश्वविद्यालय अधिनियम 1973 के प्राविधानों के अन्तर्गत संस्था को प्रदान की गई सम्बद्धता वापस लिये जाने की कार्यवाही नियमानुसार की जायेगी।
